1. Discuss and Consider Billboard located on East Main in Eastland

Director Tom Bailey introduced this item and provided some options for the sign on the north side of E. Main by the Leon River. He stated that these are just concept ideas that he thought would give us an idea of what we might like.

Discussion centered around one of the ideas "Eastland Economic Development, Inc For Our Community" "Strong Foundation".

2. Hear Update on Workforce Solutions Office Space

Tom Bailey advised that Terry Simmons has done all of the work on this subject. In the last meeting it was mentioned that Workforce Solutions had a sum of money available to update the Eastland County Museum bathrooms and install a power door on the front of the building, as well as to place some signage on or near the elevator. Terry has received bids from a plumber, an electrician, a carpenter and the person who will install the door. He is waiting on one more bid from another electrician.

3. Discuss and Consider sale of the Benifiel Property, located on Interstate 20, to McLaw Ventures, Inc

Tom Bailey stated that he recently spoke with Mr. Lawson who has the Red Star Property. He stated that Mr. Lawson's intentions are to begin demolition of the current building and build the new building and have it occupied by February 2021. Mr. Lawson asked Mr. Bailey if the Benefiel Property is still available, that he is still interested in purchasing it.

Discussion centered around the fact that the board would like to see some progress being made on the Red Star Project before they consider selling the Benefiel property to Mr. Lawson.

Director Bailey gave updates on several ongoing projects:

Maverick Logistics: He stated that the building is going up quickly and looks really good. It makes the lot look like a business. There was some delay on completion of the man hole but things should be underway soon.

Morgan Property: There has been some additional cleanup taking place and the property continues to be improved.

El Reno: Quite a bit of the grading and clearing has been completed on the lot that they will be occupying in the back of the business park and it is looking much better.

Woodlands Nursing Home: Construction is moving rapidly and discussion is underway between City Manager Ron Duncan and the city engineers to design the street and move the project forward.

Rural Health Clinic: The \$100,000 check for the parking lot has been received.
