He stated that within the next couple of weeks, he will be meeting with Eastland County Tax Appraiser Randy Clark and Developer Nicholas Petroff to work out the details of the assistance EEDI will be providing to the new County Appraisal District building and new addition that is being developed. Mark Pipkin stated that the initial speculation is EEDI will be help with funding for 300 feet of roadway leading from the Eastland County Crisis Center to the new Appraisal District building.

Executive Director Ryder Warren also spoke about a meeting that City Manager JJ Oznick and himself attended in Comanche at TOTELCOM. He stated they were very impressed with their operation and are still looking forward to TOTELCOM coming to Eastland.
