2. DISCUSSION AND CONSIDERATION OF REQUEST BY BRYAN JACKSON FOR A POLICE ESCORT TO SPUR 490 DURING HIS ATTEMPT AT A WORLD RECORD ON APRIL 13, 2019, OF RIDING A MOTORCYCLE ON ONE WHEEL FROM EASTLAND COUNTY COURTHOUSE TO CISCO.

Chairman Larry Vernon announced this item and Cecil Funderburgh explained that in conjunction with Rip’s Ribs Cookoff on April 13, 2019, Bryan Jackson will attempt a World Record of riding on one wheel from Eastland County Courthouse to the old Allsups in Cisco on 8th St.

Mr. Funderburgh advised that he had spoken with Chief Hullum and he agreed to provide an escort to Spur 490. This will be in conjunction with the Eastland County Sheriff’s Department. He stated that this attempt will be video recorded and that media will be there. He also said that this will be an excellent opportunity for great publicity for the community.
