



Roofing Contractors, Dent Repair Services

The City of Eastland requires any non residential businesses to acquire an Itinerant Vendor's Permit. These are available at the Eastland Police Department, 416 S. Seaman St.

Sec. 8-93. License required.

(a) *Solicitation* It shall be unlawful for any person to go from house to house or from place to place in the city soliciting, selling or taking orders for or offering to sell or take orders for any goods, wares, merchandise or services without having obtained a current license to do so from the city, in compliance with the terms of this article.

(b) *Itinerant merchant* It shall be unlawful for any itinerant merchant, as defined herein, his agents, employee, servant or representative to sell, offer or exhibit for the purpose of taking orders for sale thereof, any goods, wares, services or merchandise in the city without having obtained a current license to do so from the city, in compliance with the terms of this article.

Sec. 8-95. Application for license.

Any individual, firm, association or corporation desiring a license required by this article shall make written application to the police department, on a form to be furnished by the police department. The application shall show the following:

(1) The full name and address of the applicant and his social security number, driver's license number or other state identification number, the name and address of the person, firm or corporation, if any, that the applicant represents; authority of the applicant to act for the cause he purports to represent.

(2) The description and license number of all vehicles to be used by the applicant.

(3) The address where the temporary business will be carried on and a letter from the property owner giving the vendor permission to use the property for selling and delivering goods, wares, merchandise.

(4) The type of goods, merchandise, wares or services offered for sale;

(5) The period of time the applicant wishes to sell or solicit in the city.

- (6) Whether the applicant, upon any sale or order, shall demand, accept or receive payment or deposit of money in advance of final delivery.
- (7) Said applicant must furnish a copy of his active limited sales and use tax permit to complete the application information.
- (8) A statement as to whether or not the applicant has been convicted of any crime and the nature of the offense.
- (9) In addition, the police department may require said applicant to furnish photograph and fingerprint identification to complete the application information.

Sec. 5-18. Permit required; fine.

It is unlawful for any person to construct, modify or install any water or sewerage system within the city or to construct or **modify any new or existing structure** therein unless a building permit has been issued therefore in accordance with the terms and provisions of this article. Any person who violates this section shall be deemed guilty of a misdemeanor, and upon conviction thereof shall be punished by fine not to exceed \$200.00. Building Permits may be acquired at Eastland City Hall, 113 E. Commerce St.

It is also against City Ordinance to place business signage within any state or city right of way, etc.

SECTION 4. SIGN REGULATIONS – OFF PREMISE SIGNS NOT ALLOWED

4-6 Prohibited Signs: The following signs are prohibited:

- (a) Wheeled Signs
- (b) **Off Premise signs located within the City of Eastland**
- (c) **All signs in public street rights-of-way, public easements, alleys or upon any utility pole**, except those signs that are exempt pursuant to Section 4-5 Exempt Signs.
- (d) Signs that contain flashing lights that resemble emergency lights, strobe lights or any light(s), which may resemble a governmental emergency beacon or traffic control device.
- (e) Billboards
- (f) Neon Signs on the exterior of any building located within the Local Business District (C1)
- (g) Signs which use supports such as trees, rocks, bridges, fences, windmill towers, dilapidated buildings
- (h) Signs with flashing, blinking, or traveling lights, which exceed thirty-five (35) watt light bulbs.
- (i) Signs, sign structures, or supports, that project over any property line, except a sign placed flat against the wall of the building, which is on the property line, may project eighteen (18") over the property line.
- (j) **Sidewalk signs or curb signs.**
- (k) Any signs which resemble an official traffic sign or signal.
- (l) Any sign which emits sound, odor, or visible matter, which serve as a distraction to persons within the public right-of-way.
- (m) Signs which contain statements, words, or pictures of an obscene, indecent, or immoral character that would offend public morals or decency are prohibited.
- (n) Signs placed on the side or rear of any building or property when such sign faces upon a contiguous residential area
