3. Discussion and Consideration of Approval for purchase of a police vehicle using ARPA Funds

Chief Tim Pitts stated the Eastland Police Department is needing to rotate one of the old very high mileage units out. If approved, this vehicle will fit our needs and stay with the fleet image we are looking for. We are requesting the vehicle be purchased with the American Rescue Plan Act Funds.

We have received three (3) bids:

- 1. Grapevine Dodge Total \$71,053.57
- 2. Arrow Ford Total \$ 78,549.57
- 3. John Jones Pursuit Vehicles Total \$73,682.57

Chief Pitts asked the commission to approve the bid from Grapevine Dodge.

Commissioner Shirley Stuart made a motion, seconded by Commissioner James Doyle to approve the purchase of the vehicle through Grapevine Dodge for \$71,053.57 using ARPA funds
