Engineers from Enprotec Hibbs & Todd, Jonathan Baum and Sage Diller, shared with the commission that JR West Texas Contractors had submitted a bid of \$6,159,455 to complete the project. This will allow all of the streets to be completed that we are most interested in.

City Commission Meeting

City Manager J.J. Oznick reminded the commission that this is the project that began in 2018. The pandemic brought everything to a halt and when everything eventually got back up and going, and we went out for bids, the bids came in at almost double the original prices. At this point, our only options were to either ditch the project completely, which would have caused us to have to start the process all over again because this project is a necessity, or we could ask for funds from the Texas Water Development Board.

We are asking permission to release the bid to Fambro Construction, who has been holding this bid consistently since 2023. This is in order to get the construction going while we wait for TWDB to close out on the second part of the initial funding, which is \$1.3 million. That closing is supposed to begin in the middle of October.

Engineers from Enprotec Hibbs & Todd, Jonathan Baum and Sage Diller stated that by releasing the bid to Fambro at this time, the contract process will begin and by the time it is finished, it should line up with the closing of the loan process from the TWDB. Another reason to get it started now is that a portion of this water pump line will be under Lago Vista Blvd. The goal is to have that portion of the pump line completed before the new concrete flumes are constructed along Lago Vista Blvd.

Commissioner Richard Rossander made a motion, seconded by Commissioner Shirley Stuart to approve construction contract award for Water Line Improvements funded thru the Texas Water Development Board (TWDB) Drinking Water State Revolving Fund (DWSRF) #62769, contingent upon Agency concurrence.
