Mayor Larry Vernon stated that since President Trump has extended his recommendations until April 30, 2020, we should consider extending our Declaration of Local Disaster until May 18, 2020 which is the next Commission meeting after April 30, 2020. Commissioner Zac Darr stated that his understanding regarding this Declaration of Local Disaster is in order to allow our city to be eligible to receive Federal Reimbursement Funds when available.

Commissioner Ben McNabb also stated that in order for small businesses to receive any funds from the Small Business Administration, this Declaration has to be in place.

Commissioner Cecil Funderburgh made a motion, seconded by Commissioner Richard Rossander to adopt the extension of Declaration of Local Disaster Due to Public Health Emergency to May 18, 2020.
