1. Discussion and Consideration to Approve Resolution No. 2021-08
Canvassing the Election Returns and Declaring the Results of the
May 1, 2021 General Election

Commissioner Cecil Funderburgh made a motion, seconded by Richard Rossander, to approve Resolution No. 2021-08.

ASSISTANT TREASURER: Commissioner Richard Rossander nominated Commissioner Ben McNabb. Commissioner Cecil Funderburgh seconded and nominations ceased. The motion prevailed with Commissioner McNabb abstaining from the vote.

ASSISTANT TREASURER: Commissioner Richard Rossander nominated Zac Darr. Commissioner Cecil Funderburgh seconded and nominations ceased. The motion prevailed with Commissioner Darr abstaining from the vote.
